**UPDATE ON THE PRIVATE PLACEMENT OF 62,000,000 NEW ORDINARY SHARES IN THE CAPITAL OF SBI OFFSHORE LIMITED**

*Unless otherwise defined, capitalised terms herein shall have the same meaning as ascribed to them in the Company's announcements dated 23 September 2014 and 15 October 2014 in relation to the proposed placement of 62,000,000 new ordinary shares in the capital of the Company (the "Announcements").*

Further to the Announcements, the Board of Directors of the Company wishes to announce that 35,000,000 Placement Shares had been allotted and issued today. The 35,000,000 Placement Shares are expected to be listed and quoted on the Catalist Board of the SGX-ST on or around 29 October 2014, and trading of the 35,000,000 Placement Shares will commence with effect from 9.00 a.m. on the same day.

The 35,000,000 Placement Shares were allotted and issued free from all claims, charges, liens and other encumbrances and shall be freely transferable and rank *pari passu* in all respects with the existing issued Shares except that they will not rank for any dividends, distributions or entitlements, the record date for which falls on or before 27 October 2014.

It should be noted that the LQN is not an indication of the merits of the Proposed Placement, the Placement Shares, the Company, its subsidiaries and their securities.

Following the allotment and issuance of the 35,000,000 Placement Shares, the issued and paid-up share capital of the Company has increased from approximately S\$17,248,627 comprising 187,680,100 Shares to approximately S\$26,366,127 comprising 222,680,100 Shares.

In addition, due to traveling commitments of the relevant personnel of Millennium, which is one of the placees, the Company has agreed to grant them an extension of time to make the necessary payment for the subscription of 27,000,000 Placement Shares by not later than 5:00 pm on 31 October 2014, subject to the relevant regulatory approvals.

The Company will issue the 27,000,000 Placement Shares to Millennium only upon the full payment being made by Millennium.

The Company will make relevant announcement on the listing and quotation of the balance of the 27,000,000 Placement Shares to be issued at a later date.
