**STRIKING OFF OF A DORMANT SUBSIDIARY**

The board of directors (the “**Board**” or “**Directors**”) and the liquidator of SBI Offshore Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wish to announce that Solar Energy Investments Pte. Ltd. (“**SEI**”), a wholly-owned subsidiary of the Company, which became inactive since 13 October 2017, had submitted an application to Accounting and Corporate Regulatory Authority (“**ACRA**”) for its name to be struck off the register pursuant to Section 344A of the Companies Act, Chapter 50 of Singapore (“**Striking Off**”). On 2 June 2021, ACRA granted approval of the Striking Off by e-mail.

ACRA will strike off SEI’s name from the register of companies (“**Register**”) upon expiration of 60 days after publication by ACRA in the Gazette of a notice on the intention on Striking Off and no objections to the Striking Off were received.

The Company will update shareholders when the ACRA has struck off SEI’s name from the Register and publish a notice in the Gazette of SEI’s name having been struck off.

The Striking Off is not expected to have any material impact on the net tangible assets or earnings per share of the Company and the Group for the financial year ending 31 December 2021.

Save for their respective directorships and/or shareholdings in the Company (if any), none of the directors or the controlling shareholders of the Company or any of their respective associate, have any interest, direct or indirect in the Striking Off.
